CHAPTER ONE

1.0 INTRODUCTION

1.1 Background

Since 1988, successive governments have been implementing the policy of decentralization, with the purpose of creating and strengthening all-inclusive, participatory and accountable form of governance at the local level. The objective of decentralization is to bring decision-making process closer to the doorsteps of communities and to facilitate direct participation of the people in the governance processes.

In the pursuit of this objective, Metropolitan, Municipal and District Assemblies (MMDAs) are the institutions through which the objectives of decentralization are to be achieved. It is the responsibility of MMDAs to ensure greater efficiency, accountability and effective service delivery to promote effective Local Economic Development. (LED)

It is for this reason that, the Kwabre East Municipal Assembly prepared the District Medium Term Development Plan (DMTDP) under "Agenda for Jobs: Creating Prosperity and Equal Opportunity for All" (2018-2021) for effective implementation of programmes and projects to achieve its goal and objectives for the period. For effective monitoring and evaluation of the DMTDP, a Monitoring and Evaluation arrangements have been made as part of the plan to help the Assembly put an effective Monitoring and Evaluation system in place to demonstrate the extent to which they achieve the objectives and the benefits of decentralization.

In the implementation of programmes and projects in the DMTDP, substantial resources would be invested with support from Central Government and Development Partners. It is therefore important to share with stakeholders the extent to which the goal and objectives of the DMTDP have been achieved in the Annual Progress Reports (APRs).

The report covers the activities during the third year (2020) of implementation of the DMTDP (2018-2021). It takes a look at the purpose of the M&E activities for the year, processes involved, summary of achievements and challenges encountered. It also looks at issues addressed, those yet to be addressed and the way forward.

1.2 Summary of Achievements and challenges

The table below shows the summary of achievements in the implementation of programs and projects in the 2020 Annual Action Plan.

1.4 Purpose of 2020 Monitoring and Evaluation Activities

The 2020 Progress Report covers the status of the third year of implementation of the District Medium Term Development Plan (2018-2021) under "Agenda for Jobs: Creating Prosperity and Equal Opportunity for All" (2018-2021).

The report has been put together from the assessment of a set of indicators and targets, which have been adopted for monitoring, and evaluating the achievements of programmes and projects implemented in 2020.

The purposes of the report are as follows:

- Provide single source information on the level of achievement of the goals and objectives of the DMDTP (2018-2021).
- Make recommendations for addressing the weaknesses and the challenges.

The report provides an update on the status of actions taken on programmes and projects implemented in 2020 within the framework of the DMDTP. It covers these specific areas:

- Programmes/ projects status 2020
- Update on Revenue sources and Expenditure
- Update on indicators and targets
- Update on Critical Development and Poverty Issues
- Evaluation and Participatory M&E

The report has been presented in three sections. The first part looks at the purpose of the 2020 M&E, processes involved and the difficulties encountered in the preparation of the report and the status of implementation of the DMTDP.

The second section presents the M&E Activities Report, which includes update on Revenue sources and expenditure, indicators, targets and critical development and poverty issues. The last section considers the key issues addressed and those yet to be addressed and some suggested recommendations.

1.5 Processes Involved

Data used in the preparation of this report was obtained from the various sectors and departments of the Municipality. The MPCU then analyzed the data and organized them into this report. Some reports were also taken from activities of involving stakeholders.

1.5.1 Processes used in Monitoring and Evaluating the DMTDP

The Municipal Planning Coordinating Unit (MPCU) performed its Monitoring and Evaluation of the DMTDP by:

- Convening quarterly District Medium Term-Development Plan (DMTDP) performance review meetings with stakeholders
- Undertaking periodic project site inspections and meetings
- Collection and collation of data (feedback) from stakeholders for preparation of quarterly and Annual progress reports
- Dissemination and awareness creation of Government programs and progress reports at the District and Sub-District levels, among other activities.
- A Town Hall meeting was organized at Mamponteng with stakeholders to get a feedback on the Assembly's Service delivery

1.5.2 Difficulties Encountered

- Difficulties of getting data timely from the various sectors and departments.
- Inadequate and irregular release of resources for Monitoring and Evaluation activities.

CHAPTER TWO

MONITORING AND EVALUATION ACTIVITIES REPORT

2.0 Introduction

This chapter covers the Monitoring and Evaluation activities categorized under the "Agenda for Jobs: Creating Prosperity and Equal Opportunity for All" (2018-2021) development areas such as Economic Development, Social Development, Environment, Infrastructure and Human Settlements, Governance, Corruption and Public Accountability and Ghana's Role in International Affairs. It shows the implementation, status of programs and projects. It also entails the update on revenue sources and expenditure, update on indicators and targets, update on critical development and poverty issues.

2.1 ENVIRONMENT, INFRASTRUCTURE AND HUMAN SETTLEMENTS

2.1.1 Introduction

The natural and the built environment constitute major resources for development. In order to achieve our development aspirations, natural resources such as minerals, land, water bodies, forests and the atmosphere must be well-managed and prevented from being a constraint. In the same way, built environment including economic and social infrastructure should be improved in support of development while ensuring Human Settlement Planning does not lag behind Economic and Social Development Planning.

The key focus areas during the year were to reshape some deplorable roads, construction of drains, extension of electricity provision of street lights tackle the issue of development control and provide some potable water in the Municipality.

2.1.2 Rehabilitation of Roads

The objective was to reshape at least 35km of roads in the Municipality. By the end of 2020, 60km roads were reshaped.

2.1.3 Maintenance of Grader

The Grader had been fully repaired for reshaping of roads. The Municipality was opened up to facilitate economic activities.

2.1.4 Development Planning and Management

There has been public education on proper land use and preparation of local planning schemes. At the end of 2020, as many as 182 development applications were vetted, 178 were however considered for approval. The remaining development applications were rejected due to fake allocation paper. Also, there was a stakeholder meeting with chiefs of Antoa, Abirem and Adanwomase on the need to have planning schemes.

2.1.5 Sustainable Natural Resource Management

The issue of environment has become very critical as it affects the socio-economic development of the Municipality. As a result, of the irresponsible exploitation of our natural resources, irreparable damage has been done to productive land through deforestation, air and water pollution and the general destruction of biodiversity.

As the Municipality is fast becoming urbanized, efforts must be made to tackle some of the challenges to mitigate their negative effects. Fortunately, there is no issue of mining in the Municipality.

2.1.5.1 Tree Planting and Prevention of Domestic and Bush Fires

In order to protect the environment and in an effort to fight the adverse effects of climate change, tree planting exercises was organised at Wadie Adwumakase and the surrounding communities.

There was also some community education on prevention of domestic and bush fires by the Municipal Fire Service and National Disaster Management Organization (NADMO) in 10 communities in the Municipality. There has been some education on the effects of climate change on the environment as a result of negative human practices.

2.1.5.2 Bye Laws to Protect the Environment

The Bye-Laws to prevent destruction of water bodies and other environmental issues were revised and saw major enforcements as some structures in water ways have been earmarked for demolition.

2.1.5.3 Community Education on Sustainable Environment

Some community education was also organized by the information Services Department, Physical Planning Department and the Works Department.

2.2 ECONOMIC DEVELOPMENT

The key objectives of this thematic area under the District Medium Term Plan are to promote Agriculture, facilitate Industrial Development, promote Tourism and Local Economic development. Another objective is to improve the Internal Revenue Mobilization.

2.2.1 Agricultural Development

2.2.2 Introduction

The objective is to increase the output of the major crops and livestock through Modernization of Agriculture in Ghana (MAG) and Planting for Food and Jobs Programme.

2.2.3 Modernized Agriculture

Table 2.2 shows selected indicators on food crops. Cassava recorded a production level of 2,931.7mt for 2020. It remains the dominant food crop in the Municipality.

2.2.4 Modernizing Agricultural in Ghana (MAG)

During the year, 7,304 people benefitted from the programme. Most activities in the 2020 MAG work plan were implemented. Below are some of the activities carried out:

- Sensitized 100 farmers on health (HIV/AIDs)/ nutrition and child labour
- Trained 634 vegetable farmers on identification of approved agro-chemicals, proper handling, use and disposal of chemicals and their containers
- Trained 442 maize farmers on fall armyworm identification and management
- Educated 164 women farmers on nutrient-rich foods to bring down stunting and underweight in children
- Sensitized 1,316 farmers on 2020 planting for food and jobs and recovery of PFJ inputs debts.

2.2.5 Planting for Food and Jobs Programme

The Government introduced the Planting for Food and Jobs Programme in the third quarter of 2017 and the Municipality took advantage of this programme to ensure food security and creation of jobs especially for the youth. The programme covers crops such as maize, rice, tomato and pepper. During the year, 3,361 people benefitted from the programme. The objective of increasing food production, increasing farmers' income and achieving food security was largely achieved.

2.2.6 Measures to improve on the situation.

Extension coverage needs to be increased to get to more farmers with improved farming technologies. Poultry and livestock farming should be given the necessary attention and support.

2.3 Private Sector Development

2.3.1 Tourism

The Municipality can boast of tourism in terms of handicrafts such as Kente weaving, Adinkra making and wood carving. The Municipal constructed a weaving center at Abira in 2020 to boost tourism development. The number of tourists arrivals in the Municipal reduced as a result of the out break of Covid-19 in 2020. As a result the number of tourists' arrivals at Adanwomase Tourist Centre reduced from 1,885 in 2019 360. The table below shows the number of tourists' arrivals for both foreign and local from 2017 to 2020.

2.3.2 Skills Training

The Business Advisory Centre (BAC) of the National Board for Small Scale Industry (NBSSI) in the Municipal facilitated the training of artisans (dressmakers, Kente Weavers and Sellers, and Adinkra Makers) and market women in the Municipality to upgrade their Skills.

2.3.3 Women Economic Empowerment

The Business Advisory Centre (BAC/NBSSI) in the Municipality organized series of training programme to enhance Local Economic Development (LED) activities and to empower women economically by giving them skills and start up support for them. The table below shows the programmes and the number of people that benefitted, all the programmes were community based.

The preceding table (2.4) shows more women benefited from all the programmes organized by the Business Advisory Centre (BAC) of the National Board for Small Scale Industry in the Municipality. Clearly, the programme is geared towards empowering the women and the youth economically.

2.3.4 Support to Medium and Small Scale Enterprise (MSE)

The Business Advisory Centre assisted 567 persons (143 males, 414 females) under CAPBuss Adom category in assessing credit worth GH¢ 423,005. The objective of promoting local economic development is being pursued.

2.4 Revenue Performance

The objective is to improve revenue collection and to enhance service delivery in the Local Governance System.

2.4.1 Internally Generated Funds

The Municipality recorded an Internally Generated Revenue of GH¢ 1,445,238.23 as against a target of GH¢1,733,677.70 representing 83.4% in 2020.

2.4.2 Update on Funding Sources (GH¢)

The table below shows update of funding sources from 2017 to 2020. The DACF continues to be the main source of the Assembly especially for investment projects.

The shortfall in our revenue receipts affected the full implementation of programmes and projects. The Assembly's inability to achieve its Internally Generated Revenue target was mainly due to the COVID-19 pandemic.

2.4.3 Measures and Strategies to improve the situation

- Tax evaders are to be prosecuted in the course of the year
- Training of revenue collectors to update their skills has started
- All commercial properties have been revalued
- Motivation of Revenue collectors in terms of logistics has improved
- Use of Information, Communication and Technology in the revenue mobilization process
- Public education on the need to pay taxes has been intensified
- Service delivery to the citizenry has improved. Many roads are being graded
- NABCO trainees have been trained for data collection of properties and revenue collection

2.4.4 Efforts to Generate Funds

The efforts being made to generate more funds include:

- Educational campaign on revenue generation is being undertaken.
- Provision of training, incentives and logistics to revenue collectors.
- Enforcement of bye-laws to prosecute defaulters.
- Revaluation of properties.
- A dedicated vehicle for revenue mobilization

All these are being implemented

2.5 SOCIAL DEVELOPMENT

2.5.1 Introduction

The following priority areas under Social Development have been considered; Education and training, Health Services, Water and Environmental Sanitation, Gender, Disability and other Social protection issues.

2.5.2 Education

The following policy objectives were identified under the strategy to improve educational outcomes necessary for ensuring greater access to education;

- To improve upon BECE results.
- To improve educational infrastructure

2.5.2.1 Gross Enrolment Rate

2.7 MANAGEMENT OF WATER AND SANITATION FACILITIES

2.7.1 Environmental Health and Sanitation

There has been regular clean up exercises in the communities. Twenty cleanup exercises were organized in 20 communities during the year. Public education against open defectaion was also done in many communities to advise them to get toilets in their houses.

The Assembly's contract with Zoomlion Ghana limited, continues to improve the sanitation situation in the Municipality. There was also regular fumigation exercise by Zoomlion in the Municipality. Five refuse dumps have also been evacuated at Ahwiaa, Mamponteng, Abosso and Kenyase

2.7.2 Safe Water and Sanitation

Twenty-Five (25) communities have benefitted from the drilling and mechanization of 25 No. mechanized boreholes. Communities that have benefitted include Ntonso, Ahwiaa, Asonomaso, Abirem and Aboaso.

2.7.2.1 Measures to improve the Situation

- Acquisition of additional dumping site
- Intensify education on household latrines promotion
- Expansion and extension of water and sanitation facilities
- Education on good sanitation practices should be intensified

2.8 Governance, Corruption and Public Accountability

The overall objectives of this thematic area under the District Medium Term Plan are to improve service delivery, increase participation in local governance and improved security.

2.8.1 Functional Sub-District Structures

There are 6 zonal Councils, efforts are being made to make all of them functional. Personnel have been posted to all the councils and some logistics have been provided. Some revenue items have been ceded to them for collection.

2.8.2 Security Issues

The number of police personnel in the Municipal is 101 (37 females, 64 males). There are still 3 police stations in the Municipal. Also, there are 43 Fire Service personnel in the Municipal comprising 30 males and 13 females. The Municipal fire service has one fire truck.

2.8.3 Capacity Building

Training workshops were organized in Proposal Report and Minute Writing, Local Governance Act, Conditions of Service, National Pensions Act (766) and code of conduct for 117 staff (59 Males and 58 Females).

2.8.4 National Celebrations

The 63rd Independence Day Celebration took place on 6th March, 2020. In attendance were the Municipal Chief Executive, Municipal Coordinating Director, Head of Departments and agencies in the Municipality. There were parades of basic and second cycle school children.

The 2020 National farmer's day was celebrated on 6th December, 2020 at Bamang. In attendance were, the Municipal Chief Executive, Municipal Coordinating Director, Heads of Department and agencies in the Municipality, all Assembly members, some chiefs, farmers and the public.

From the above table, there were positive outcomes in terms of all indicators despite the outbreak of COVID-19. Access to portable drinking water has also improved from 68% in 2019 to 87.5% in 2020. Information on the Net enrollment ratio, Gender parity Index and completion rate were not available.

Information on sorghum, groundnut, cowpea and soya beans could not be obtained. These are not major crops cultivated in the District. They were replaced with Yam, Tomato, Pepper and garden eggs.

2.8.5 Child Right Promotion and Protection

To ensure that children are safe and protected from abuse, the Department of Social Welfare undertook public education programs in some selected communities in order to achieve this objective. The department also visited the only children's home in the Municipality (Nana Deborah's Safe Haven Home) nine times to inspect the premises and the living conditions of the children in the home.

In addition, 102 cases consisting of child maintenance, child custody, family welfare, Paternity and various forms of abuse were registered. During the quarter 13 community/ child protection durbars were organized. In all 1,512 audiences (539 males, 973 females) attended the programme. Topics discussed included child abuse, child neglect, exploitation and domestic violence.

2.8.6 Vulnerability and Social Protection

Vulnerability is a cross-cutting issue and some aspect of it has already been reported under the various thematic areas. However, it is important to look at the issues of people with disabilities, gender and poverty issues.

2.8.7 Database on People with Disability

Database on People with Disability (PWDs)

In order to manage the issue of disability effectively, existing database on people with disability was updated by the Department of Social Welfare. By the of end of 2020, 66 PWDs consisting 30 males and 36 females were registered as indicated in the table below.

2.8.8 Registration of Indigenes under Health Insurance Scheme

At the end of 2020, 2,443 (1,347 females, 1096 males) indigenes were registered under the National Health Insurance scheme. This was to enable them have access to quality health care. Also, 7,286 LEAP beneficiaries list has been submitted to NHIS to be enrolled on the scheme.

2.8.9 Financial Support for PWDs

The Municipal Assembly received an amount of GH¢ 33,262.50 and GH¢ 50,273.32 for the 3rd and 4th quarter of 2019. Also GH¢28,610 and GH¢ 33,262.50 were received for 1st and 2nd quarter of 2020. The amount has been disbursed to 135 PWDs.

2.8.10 Livelihood Empowerment against Poverty (LEAP)

By the end of 2020, six (63rd to 68th) LEAP payment cycles were supervised by the Department of Social Welfare to 5,906 households. A total amount of GH¢501,856.32 was paid for all the cycles.

2.8.11 National School Feeding Programme (NSFP)

The Municipality has been benefiting from the National School Feeding Programme. As at the end of 2020, 55 basic schools were benefiting from the programme. The programme has increased enrolment in the beneficiary schools.

As many as 20,751 pupils comprising 10,290 boys and 10,461 girls are benefiting from the programme. The number covers pupils between the ages of 6 to 12 years in the pre-school and the primary school.

2.8.12 NATION BUILDERS CORP (NABCO) – 2020

The Nation's Builders Corp (NABCO) is a government initiative introduced in 2018 to address graduate unemployment. In 2018, 1,353 unemployed graduates were employed into the various modules of NABCO. An additional 84 trainees were received in the month of January 2019. However, some of the trainees have received appointments in GES, Ministry of Local Government and Ghana Health Service so the total number has reduced from 1,353 to 1,106. The table below shows the various modules and the number employed under the various modules.

Key stakeholders who took part in the programme were Assembly Members, Unit Committee Members, Opinion Leaders, Contractor, Heads of Departments and Civil Society Organisations (CSOs).

2.10. Evaluations Conducted Findings and Recommendations.

The evacuation of two huge refuse dumps were completed by the end of 2020. A baseline survey on the impact of huge refuse at Mamponteng Zongo and Aboaso was conducted. The findings showed that there was Prevalence of sanitation-related disease such as malaria, cholera, unpleasant smell and part of the refuse getting into people's houses among others.

Also an Impact Assessment was done after the evacuation of refuse at Mamponteng-Zongo and Aboaso. The findings showed that there has been reduction in the prevalence of sanitation related disease, Improvement in the management of refuse among others. CHAPTER THREE

3.0 The Way Forward

This chapter takes a look at the way forward. It covers key issues addressed and those yet to be addressed as well as recommendations to guide future implementation of programs and projects.

3.1. Key Issues Addressed and those yet to be addressed

The 2020 Progress Report, reviews the performance of the Assembly under the five (5) development areas of the National Medium Term Development Policy Framework (Agenda for Jobs: creating Prosperity and Equal Opportunity for All, 2018-2021) has been examined. Not much achievement has been made in 2020. A lot more needs to be done to achieve the goals and objectives of the Municipal. A number of important issues need to be addressed to enable the Municipal achieve its goal of improving the life of its people.

3.1.1 Key Issues Addressed

Key issues addressed include

- Improvement in educational infrastructure and effective supervision.
- Improvement in health infrastructure.

Issues yet to be addressed

Some issues yet to be addressed include;

- The issue of poor sanitation, poor solid waste management has been a major issue in the Municipality.

 There are many heaped refuse dumps left to be evacuated.
- The issue of poor roads in the Municipal. The Municipal is more accessible in terms of the road network. However, most of the roads are very bad and need to be tackled very seriously.
- Also the construction of the Jubilee market at Mamponteng which started in 2012 needs to be completed. This has been an issue in the capital since traders do not have places to sell their goods and drivers of public transport had been forced to park haphazardly.

3.2 Recommendation

1. There is the need to build the revenue generation capacity of the Assembly. More effective financial accountability mechanisms need to be introduced especially with regards to internal revenue mobilization and utilization.

- 2. There is the need to improve on the data collection mechanisms. Capacities must be built in data management.
- 3. Programmes and projects for execution must emanate from the District Medium Term Development Plan.
- 4. There is also the need to make the MPCU more functional. The MPCU needs to be supported financially and logistically for effective implementation of its activities.
