## **CHAPTER ONE**

### **INTRODUCTION**


### **1.1 Background**

The Local Governance Act (936) 2016, enjoins all MMDAs to plan, implement and source for funding for their development programmes in their respective jurisdictions. In line with the above objective, MMDAs are mandated to prepare their development plans execute such plans, monitor and evaluate the programmes and activities in those plans as a way of ensuring that those activities and programmes achieve the desired impact.

The North Gonja District Assembly as part of its obligation to ensure the total development of the District has implemented a four-year Medium Term Development Plan (MTDP), (2018-2021) The DMTDP under the MTNDPF; **An Agenda For Jobs: Creating Prosperity And Equal Opportunity For All 2018-2021** has been mainstreamed with the Sustainable Development Goals (SDGs), African Union Agenda 2063 and the Paris Climate Change Agreement (COP21).

As part of the processes leading to the attainment of goals and objectives that were set for the year, it was necessary for the District Planning and Coordinating Unit to assess the extent of implementation of the plan. This report therefore covers programmes and activities carried out by the District Assembly and its departments and also the financial position of the Assembly from 1<sup>st</sup> January to 31<sup>st</sup> December, 2020.

The Annual Progress Report (APR) for 2020 is presented in three (3) chapters. Chapter one (1) presents an introduction which entails the summary of achievements and challenges with the implementation of the District Annual Action Plan (AAP) for 2020, the purpose of the Monitoring and Evaluation (M&E) activity for the Quarter and Processes involved as well as the challenges encountered. Chapter two (2) presents M&E activity reports which entails the assessment of program/project status, updates on funding sources and disbursements, updates on core indicators and targets as well as updates on critical development and poverty issues. Also presented here include findings and recommendations on development evaluations conducted during the year and findings on participatory evaluation conducted. Lastly, the chapter three (3) is focused on key issues addressed and those yet to be addressed as well as recommendations and the way forward.



### **1.3 PURPOSE OF MONITORING & EVALUATION FOR 2020**

The 2020 Annual Progress Report is the third report on the implementation of the North Gonja District Medium-Term Development Plan (2018 - 2021). The main purpose of the report is to assess the progress made in the implementation of programmes and projects as outlined in the DMTDP (2018 – 2021), An Agenda For Jobs: Creating Prosperity And Equal Opportunity For All 2018-2021

### The purpose and objectives includes;

- To identify successful strategies for replication as well as unsuccessful strategies for modification
- It demonstrates accountability to relevant stakeholders
- To enable stakeholders determine through evidence based information, the effects of the various interventions implemented over the medium term and the impact in terms of positively transforming the lives of all beneficiaries in the District.
- To ensure the implementation of planned projects and programmes and ascertain the status of development projects and programmes in the District.
- To enable the district generate reliable, valid and dependable information to the Region and National authorities to formulate policies and make evidence based decisions to further improve the lives of the people in the District.
- To institute an effective and efficient system for tracking the progress of programmes and projects in the district through systematic monitoring and evaluation of the District Annual Action Plan.

## **1.4 PROCESSES INVOLVED**

The processes the District Assembly adopted in the monitoring and evaluation of its development activities were based on the NDPC's guidelines for M&E.

- The preparation of this Progress Report started with the collection of data from the District Assembly Offices as well as decentralized departments on the status of programmes and projects carried out within the year under review. Again, there was monitoring and evaluation of completed and on-going projects in the district and the results had been collated and reported in this report
- Information was also gathered on the poverty eradication intervention programmes by government in respect of the Ghana school Feeding Programme, Livelihood Empowerment against Poverty (LEAP) among others. The data was collected, analysed and included in this report.
- The effectiveness of policies, programmes and projects is achieved by monitoring objectively verifiable indicators. Project Monitoring formally begins as soon as actual implementation of a project starts, and it is directed at ensuring progress according to schedule, standard quality of work, and the correct delivery of inputs (including labour) according to time, quality and quantity.
- Collecting Data on the implementation of Physical and Non Physical Projects through site visits, monitoring and inspection.
- Holding Quarterly M&E meetings.

• Preparation of Quarterly Progress Reports on Development Programmes and Projects

This monitoring exercise took place from between the months of January- December, 2020. The projects monitored and evaluated were funded from various sources which included DACF, GETFund, MPs Common Fund, DDF, GoG and NGO funded projects.

## **1.5 Achievement of Annual Action Plan for 2020**


The District has choked many successes in the implementation of the 2018-2021 Medium-Term Development Plan MTDP. Tremendous efforts have been made in most of the focus areas among them are increases in revenue mobilization, access to education through increased provision of educational infrastructure, increased geographical access to health services through increased provision of CHPS Compounds and Nurses Accommodations, increased access to potable water through the provision of more boreholes, improved road network, improved Agriculture production etc. The implementation of the 2018-2021 MTDP is a step in the right direction toward the achievement of the goals and objectives of the SDGs and the AU Agenda 2063 and the Paris Climate Change Agreement (COP21).

The North Gonja District Assembly had about 189 activities and projects captured in the 2020 Annual Action Plan out of which 149 activities representing 78.83% of total planned activities for the year were completed by the end of 2020, 25 activities currently on-going representing 13.23% and 15 activities representing 7.93% were yet to be executed.

This achievement will go a long way to meet the goals of the district which is "to improve the quality of life of the people by harnessing human and material resources for the provision of basic infrastructure and socioeconomic services."

## **1.6 IMPLEMENTATION OF THE 2018-2022 MEDIUM TERM DEVELOPMENT PLAN**



Health Care delivery, Sustainable Agriculture, HIV/AIDS issues, Support to persons living with Disability, Strengthening Assembly structures, local economic development, Security, sanitation, Provision of educational infrastructure, and construction of projects and completion of on-going projects took centre stage in the activities of the Assembly during the period under review.

There are 256 activities and projects captured in the 2018-2022 DMTDP out of which 189 were in the annual action plan for 2020. During the period under review, 149 activities were implemented representing 58.20%, 25 of the activities and programmes representing 9.76% were on going and 15 activities representing 5.85% were yet to be implemented. From the progress made so far, the district will continue to work in achieving the quality of lives of its people

# 1.7 CHALLENGES WITH THE IMPLEMENTATION OF THE 2020 AAP AND DMTDP (2018-2021)

During the implementation of the activities captured in the DMTDP and the AAP for 2020, a number challenges were encountered as well as during the monitoring and evaluation of the implemented activities.

- The outbreak of the corona virus (Covid 19) affected the implementation of the 2020 AAP
- Ineffective Monitoring and Evaluation of programs and activities due to inadequate resources and logistics.
- Low levels of Internally Generated Fund
- Inadequate logistics for general administration and management issues.
- Inadequate and unreliable data for planning purposes
- Ineffective Sub-structures to aid in IGF mobilization
- Untimely release of certain statutory funds such as the District Assemblies Common Fund (DACF) affected the implementation of 2020 AAP
- Poor collaboration among key stakeholders at times made implementation of programmes and monitoring difficult
- Inadequate means of transportation to enable movement to sites and other departments far away from the Assembly for information gathering.
- Poor attendance by stakeholders during the monitoring exercises.

# **CHAPTER TWO (2)**

## 2.1 Programmes and Projects Monitored

The District monitored a total of thirty-eight (38) projects and forty-five (151) Programmes. These activities were funded from District Assembly's Common Fund (DACF), IGF, GetFund, GSOP, GoG, DDF, RING, GoG Unicef, CWSA, GIZ and among others.

## **2.2 UPDATE ON FUNDING SOURCES AND DISBURESMENTS**






During the period under review 2020, A total of GHC 2,819,921.88 was receipts lower than

## 2.3 INTERNALLY GENERATED FUNDS (IGF)

The performance of the District Assembly with respect to the Internally Generated Fund (IGF) over the years has continued to decrease and this can be attributed to the nationwide banned of rosewood activities, lack of viable business activities in the district and the reluctant of people to pay rates and fees on their properties.



During the period under review, the IGF received an amount of 263,503.20 exceeding its targets set for the year and the amount received in 2019. This can be as a result of the stragegies

put in place to improve the revenue performance of the district assembly. The district assembly adopted the following strategies to increase its IGF collection

- The activation of the sub-district structures (Town and Area Councils) to increase revenue mobilization.
- The occasional use of Revenue Task Forces in revenue collection;
- Charging/fixing realistic rates/fees;
- Reliable database on revenue generation; and
- Monitoring of revenue collectors.
- Community engagements on the need to pay taxes for development activity.

## **2.4 DISBURSEMENT**

### 2.6 LIVELIHOOD EMPOWERMENT AGAINST POVERTY (LEAP)

The Livelihood Empowerment Against Poverty (LEAP) Programme is one of the components of the National Social Protection Strategy (NSPS) which was launched in 2007. Is a cash transfer Programme aimed at empowering the extremely poor, disadvantage, and vulnerable population to improve upon their lives? LEAP is implemented by the Department of Social Development under the Ministry of Gender, Children and Social Protection.

- The LEAP programme is intended to empower households with a combination of cash, conditionalities and subsequently link them to existing social protection interventions in their communities.
- The programme has a potential to increase school enrolment among children in extreme poor households, reduce infant mortality, improve nutrition, ensure birth registration etc.
- Above all the programme is intended to improve the local economy with the enhanced purchasing power of the extreme poor

There are about 65 communities in the district and only eight (8) Communities with 750 households are currently benefiting from the LEAP project. The detail is shown below.

## <u>A REPORT ON THE SENSITIZATION OF COMMUNITIES ON THE RIGHTS</u> OF CHILDREN, CHILD ABUSES AND INDISCRIMINATE BUSH BURNING

- The department of social welfare and community development as an instrument for improving and enriching rural life through literacy and education and as part of discharging its duties, embarked on the community sensitization activities on the topic stated above in seven selected communities in the district.
- On the 3<sup>rd</sup> of December 2020, the officers of the department visited some of the communities to pre-informed them about the exercise or the sensitization that will be carried on by the team. The selected communities were **Disah**, **Singa**, **Daresalam**, **Donkompe**, **Kuporto**, **Sakpala**, and **Tunsungu**. The pre-entry was effectively done.
- On the 4<sup>th</sup> of December, 2020 the team started the sensitization by visiting **Donkompe**. The community members were sensitized on the topic stated above.
- At around 9:30 am when the team arrived in the community,77 people consisting of 25 males,31 females and 21 children were participants at the meeting.

# 2.9 The School Feeding Programme

The Ghana School Feeding Programme (GSFP) is a poverty initiative targeted at poor and vulnerable pupils in deprived communities. The objective of the programme is to improve school attendance at the basic level through the provision of one hot meal per day for all pupils in the various beneficiary schools.

The North Gonja District is a beneficiary of the Ghana School Feeding Programme. The following 9 schools are beneficiary schools currently on the programme. However, efforts is being made to include some schools which have qualified but are not on the programme yet due to resource constraint. #### 2.9.1 THE BENEFICIARY SCHOOLS FOR SCHOOL FEEDING PROGRAMME

The 2020 target and the actual receipts of the Ghana School Feeding Programme (GSFP) could not be provided because the caterers are now being paid directly by the Ministry of Finance.

## **2.10 CAPITATION GRANTS**

The inability of most parents to afford levies charged in schools made some children of *school-going-age* not enrolled in schools in spite of the *free tuition* in basic schools. It's in the light of this that the MOE set up the **Capitation Grant Scheme** in 2005/2006 and an amount of GH $\emptyset$  3.00 was initially paid per head in the Public Basic Schools. The amount has since been revised twice to GH $\emptyset$  4.50 and now GH $\emptyset$  9.00 per head.

## 2.11 NATIONAL YOUTH EMPLOYMENT PROGRAMME (NYEP)

The objective of the programme is to provide jobs to teaming unemployed youth in the District and the country at large. It is also aimed at giving the youth prior and basic training in preparation for professional jobs in the areas of health, education, security among others. The programme since its implementation has carried out various modules. These included; Community Policing Assistants (CPA), Youth in Prison Service (YPS), Fire Service Assistants (FSA), Environmental Protection Assistants (EPA) and E-Health. Other modules of the programme include; Community Education Training Assistants (CETA), Community Health Workers (CHW) and Youth in Arabic Education. All these modules were implemented to the 355 youth beneficiaries in the district. The tables below were total numbers of beneficiaries so far recruited in the District under the programme:



#### **2.12 Rural Electrification Project**

Government through the Ministry of Energy and the North Gonja District Assembly has extended electricity to 5 communities in the North Gonja District. The following bar chart depicts the electricity coverage in the district.



Electricity coverage has increased from 15.38 % in 2019 to 23.08% in 2020. Another 5 communities lights are currently on-going under the SinoHydro Development Project and work is expected to be completed in 2021.

#### 2.13 One Village One Dam

One Village-One-Dam is one of the government's Infrastructural for Poverty Eradication Programmes. It seeks to provide water for dry season farming and other purposes throughout the country Under this project 6 communities in the district have already benefited from the construction of Dams so far; the communities are: Bawena, Jinfrunu, Kpulumbo, Daresalam, Yazori, Korpoto. About 1,946 people are benefiting from this Project.

# 2.14 PLANTING FOR FOOD AND JOBS PROJECT

Planting for Food and Jobs is an Agriculture social intervention aimed at supporting existing and new farmers with farm inputs by absorbing up to 50% of the initial cost of the inputs. The aim is to attract young farmers who usually do not have initial capital to purchase farm inputs for farming. The programme therefore offers farmers the opportunity to source these inputs at a 50% discount while they pay the balance after harvest and sales

To achieve its objectives, 4,312 farmers were supported with subsidize fertilizer to increase food security in the district.

## 2.15 NATIONAL HEALTH INSURANCE SCHEME (NHIS)

The National Health Insurance Scheme (NHIS) has been in operation since the creation of the district in 2012. It is a social intervention that seeks to support the poor and vulnerable in seeking health in selected ailments and medications. The West Gonja District Assembly still has oversight responsibility over the scheme as there is no NHIS office in the district. This therefore poses a challenge in Health insurance registration or renewal as clients have to travel all the way to the regional capital (West Gonja Municial-Damongo) or Tolon district of the Northern Region to register or renew their cards. For this reason, it was difficult getting the number of NHIS beneficiaries in the district

## **2.16 FREE SHS PROGRAMME**

The Free Senior High School Programme instituted in 2017 is a social intervention targeted at all Government/Public Senior High Schools. The objective of the programme is to assist all students who qualify for admission into public Senior High School to rightfully enroll and undergo their education without any financial challenges. The programme with first years of the 2017/2018 academic year. Beneficiaries include both day and boarding students of public Senior High Schools. The boarders are fed three times daily while their day students counterparts receive One Free Hot Meal (lunch) on School Days. Besides its benefit of increasing enrolment in public SHS, it has also removed from parents the financial stress and burden of taking care of their children through SHS.

With the introduction of the free Senior High School, Government has release a total of Seventy Thousand Two Hundred and Thirty-Five Ghana Cedis Fifty-Two Pesewas (GHc70, 235.52) as at October, 2020 to the Daboya Community Day Senior High Schools with total student population of 359 students.

### 2.17 POVERTY STATUS OF THE DISTRICT

The District has about 99.5% of its total area been a rural setting, with majority of the people being crop farmers. These groups of people have low living standard compared to the few at the formal sector.

The informal sector lacks the requisite technical knowhow to upgrade their means of living for decades.

These inequalities are due to challenges in economic growth. Notable among these are:

- Inadequate and poor infrastructure e.g roads and electricity coverage
- Unavailability and cost of credit
- Poor revenue and expenditure management

## **2.18.0 DEPARTMENTAL REPORTS**

#### **2.18.1 AGRICULTURE**

#### MOAP

The Market Oriented Agriculture Program is a European Union and Germany Business Ministry funded program been implemented by GIZ and MOFA-GHANA. The program supported the department of agriculture in the area of capacity building to undertake a step down training in 2018. However, in 2020, there was no step down training although staff were trained as plant doctors to take care of farmers plants that were infected by diseases. Farmers' plants were diagnosed and recommended pesticide prescribed to buy.

The program supported ten mango farmers to purchase 2400 improved grafted Mango seedlings to plant 12Ha and 10,660 grafted cashew seedlings to plant on 266.5Ha. Beneficiaries were 74 males and 3 females respectively for cashew.

#### MAG

The agricultural sector since 2017 have enjoyed massive support from the program dubbed Modernized Agriculture in Ghana. The program supported the department in the areas of financing and logistics to deliver extension services to farmers. One pick vehicle, one table top computer, 8 motorbikes and trainings have been given to the department. This has improved the delivery of services by officers in the district and more farmers are now receiving extension services compare to the pass. 21 demonstrations were carried out across the district with over 3417 male and 2141 female farmers participating. Staff capacities were built to disseminate technologies that meet farmers needs.

#### PERD

Planting for Export and Rural Development is a government of Ghana flagship program which seeks to promote the production of tree crops to diversify household incomes. The department through the district assembly supported farmers to plant 50k polyclonal seeds in 20 communities. The total area covered is 462.4Ha with 371 males and 113 females benefiting. Monitoring of the fields revealed that one third of the farms were affected by bushfires and this calls for more capacity building and prevention in the affected communities.

#### GPSNP

Ghana Productive Safety Net Project is an intervention that seeks to engage community members during the dry season when farming activities are less or non-existent through labour intensive public works at a wage. Beneficiary members of a selected community will work daily for at least six days in a week.

The department of agriculture will be implementing the climate change component of the program in two selected communities; Sinsina and Lingbinsi. The two communities will be engaged to plant cashew seedlings on marginal lands as a means of reclaiming it to its natural

status. The plantations will be owned by the entire respective community members however, seedlings will be distributed to interested farmers to establish individual plantations.

A nursery will be established at Sinsina to raise all the needed seedlings to meet the target of 20ha.

# 2.18.4 Sanitation, Environmental Health and CLTS Programme

#### **Community Led Total Sanitation (CLTS)**


The District undertook massive behavioral change communication strategies to attain a District

wide open defecation free (ODF) status. Key activities inludes

- Distribution of 200 No. toilet facilities
- CLTS monitoring in 27 communities
- House to house inspections to educate the public on hygiene behavior
- Monthly review meetings were held
- Solid and liquid waste management activities carried out
- School health education was carried out to educate pupils, teachers and food vendors on hygiene practices

In 2020, 27 communities were monitored to ensure they attain open defecation free status, out of the number, 4 communities were declared ODF during the making the total of 17 ODF communities representing 26.15% of ODF coverage in the district. The detail is as follows

From the bar chart, it can be seen that, RING Project is the leading of Open Defecation Free (ODF) communities in the district with 58.82% followed by GoG Unicef with 23.53% and CWSA with 7.65%. The total number of ODF communities in the district is 17 representing 26.15% of ODF coverage in the district.

Despite the improvement of sanitation in the District throughout the year, the unit was not able to achieve all its targets due to:

- Unwillingness of the population to change their behaviors towards environmental cleanliness
- Weak enforcement of DA by-laws.

## 2.19 Disaster Management and Climate Change Issues

Public education on flood related issues

- The location of the district makes the people naturally vulnerable to floods as the White Volta passes through some parts of the district. Children who also have to cross rivers and streams to access educational services, parents that have to cross rivers to access health service are all faced with so much vulnerability. The cases of Kayaye which is at an alarming rate has put the district in a risk zone since some of these people come back with strange diseases, putting the lives of their families at risk.
- There is also inadequate alternative social insurance and safety nets for the very vulnerable. NADMO is currently present in the district but not functional.

# **REPORT FOR SENSITIZATION ON CLIMATE CHANGE ILLEGAL LODGING**

On 22<sup>th</sup> of June, 2020 staff from the department of Social welfare and Community development went to Anyanto Wawato, Gurubagu and Donkompe, and sensitized them on the effects of felling down trees and the importance of afforestation. Community members were advised that cutting down of these trees can lead to an increase in temperatures in their communities and also reduce rainfall pattern. Again, it can also reduce the fertility of their farm lands and natural cover of the environment around them.

However, the people in Donkompe welcome the idea and promised to stop people who always come to the area to cut rosewood for commercial purposes. They complained about shortage of water in their area now a day which use not to be so when there used to be enough vegetation cover in their area.

In addition, Anyanto people realized the effects of the tree cutting and appealed to the district assembly through us to put a band on rose wood cutting in their area as it now contributes to the rise in temperature in their community which is not used to be so.

Gurubagu and Wawato people complained they tried in their owned way to stop the tree cutting but did not succeed and appealed for government intervention to help put a stop to. We promised to forward their complains to management of the district assembly for redress.

## **BUSH FIRES**

However, on the 17<sup>th</sup> of November 2020, a team visited some communities to sensitized them on the bushfire and the need to take precaution. we also in the course of the year sensitized Ziepe, Donkompe, Salugu, Disah The community members in all these communities said that the burning of the bushes is normally done by the Fulani heads men in the area and promised to call their leaders to talk to them about the issue on how to end the bush burning problem in the area. They further stated that bush burning contribute to loses in their area as some farmers in the area loss their food stuffs through bush burning and promised to help stop it.

## FLOODING

On the 12<sup>th</sup> of May 2020, the NADMO sensitized communities along the White Volta to always move to the higher places when-ever the Bagri dam is open to avoid losing lives and properties. The team visited Daboya, Guo fishing camp, Tidrope fishing camp, Gbanjogla Kura, and Sisipe communities. A total of 2157 people were supported during the year from the floods victims.

## 2.20 Gender Issues

Sensitization programme was carried out for heads of department, selected assembly members, traditional authorities on gender mainstreaming. Training workshop for women on income generating activities and how to make good use the saving from the VSLA. A total of 30 members participated in the events made up of 20 males and 10 females

## **2.21 POPULAR PARTICIPATION ACTIVITIES**

The North Gonja District Assembly sees the involvement of stakeholders as very crucial to the successful implementation of programmes and projects. In furtherance of this, various platforms have been created to enable stakeholders participate in the implementation of programmes and activities. These included Town hall meetings, Assembly meetings, radio programmes, and community forum, area council meetings etc.

As mandated by relevant legal regimes, the Assembly sees the involvement of stakeholders in the preparation of the 2020 Annual Action Plan as important and necessary. As a result, the North Gonja District Assembly organized public hearings at the three area councils to solicit the views of stakeholders in the preparation of the Annual Action Plan. Mid year, Annual, and MTDP review were also organised. Stakeholders present at the events included the DCE, DCD and staff of the Assembly, Assembly members, media, clergy, trade unions, women's groups, PWDs, representatives of the three area councils etc.

- The first of the public hearings for Daboya Area Council was organized on Tuesday, 10<sup>th</sup> November, 2020 at the Daboya Area Council Hall. Total Number of Persons at hearing was 120 Gender Ratio/Percentage represented (105 males representing 87.5% and 15 females constituting 12.5%)
- The second of the public hearings for Lingbinsi Area Council was organized on Wednesday 11<sup>th</sup> November, 2020 at the Lingbinsi Area Council Hall. Total Number of Persons at hearing was 75

Gender Ratio/Percentage represented (65 males representing 86.66% and 10 females constituting 13.33% )

 The third of the public hearings for Mankarigu Area Council was organized on Monday 15<sup>th</sup> November, 2020 at Mankarigu Council Hall. Total Number of Persons at hearing was 81 Gender Ratio/Percentage represented (62 males representing 76.54% and 19 females

constituting 23.45%)

On Wednesday 15<sup>th</sup> October 2020, The North Gonja District Assembly in its efforts to bring governance to the doorsteps of the people as well as account to the people on its mandate organized a Town Hall Meeting/ Meet the Press encounter to on the implementation of government flagship projects and programmes at the District Assembly hall for stakeholders to highlight some of the Projects/ programmes the Assembly. It was also an occasion for citizens of the District to ask questions on the activities of the Assembly as well as raise their concerns on local development. Some of the stakeholders were, chiefs, clergy, NGOS, public services etc. In all a total of 100 persons took part in the event made up of 81 males and 19 females. Covid 19 protocols were duly observed.

Specifically, it sought to:

- Highlight Developmental Projects and Programmes the Assembly has undertaken since January, 2017
- Interact with the People on decentralization and strengthen citizen participation
- Elicit views/concerns of the people
- Address some of the concerns of the people

On 25<sup>th</sup> December 2020, the DCE led a team of officers to pay a courtesy call on the Wasipe Traditional House of Chiefs. The purpose of the meeting was to interact with the Chiefs and get their views incorporated into the development processes of the Assembly. In all a total of 26 Chiefs and Queen mothers as well as elders participated in the events made up of 21 males and 5 females

# **EVALUATIONS CONDUCTED, THEIR FINDINGS AND RECOMMENDATIONS**

The type of evaluation conducted was the terminal evaluation of some projects and programmes across the sectors of education, water and sanitation and health as implemented in the 2018-2021 Medium Term Development Plan.

The Purpose of this evaluation was to ascertain the level of implementation of Planned Programs, project and activities and to assess the impact of these interventions on the intended beneficiaries.

The methods implored in undertaken the evaluation was to design a check list by the DPCU to track the progress of implementation of planned activities. Moreover, questionnaires were also designed to collate the views of program beneficiaries in order to measure their degree of satisfaction with respect to utilization of completed project and programs. The DPCU further reviewed implementation reports of various Departments concerned with the utilization of the projects and program implemented in the Plan to be able to measure reported changes against planned interventions.

Table 8 presents details of the evaluations conducted on projects in the areas of education, governance and health.

## **3.0Conclusion and recommendation**

#### **3.1 Introduction**

This chapter reports on the summary of the 2020 Annual progress report, the challenges and the recommendations to the challenges.

#### **3.2 Conclusion**

Monitoring and evaluation is an integral part of the development process. They are carried out to check the progress made on the implementation of projects that are planned for in the DMTDP of 2018-2021 as indicated earlier. The North Gonja District Assembly had about 189 activities and projects captured in the 2020 Annual Action Plan out of which 149 activities representing 78.83% of total planned activities for the year were completed by the end of 2020, 25 activities currently on-going representing 13.23% and 15 activities representing 7.93% were yet to be executed.

This achievement will go a long way to meet the goals of the district which is "to improve the quality of life of the people by harnessing human and material resources for the provision of basic infrastructure and socio-economic services."

For the District Core Indicators, some targets were achieved whiles others couldn't be realised. This can be related to low level of implemented projects. This is so alarming for the District in terms of development.

#### **3.3 Challenges**

Some challenges that were encountered by the District Assembly in the execution of their activities include;

- Inadequate logistics and lack of funds to carry out smooth implementation of planned programs and activities. This causes delays in the completion of ongoing projects and also makes it difficult to start new projects.
- Lack of accommodation for staff
- Lack of disaggregated data for the Assembly
- Low revenue performance in terms of IGF

- Inability to have properties re-valued in the district
- Delay in getting some existing information from Sector/decentralized departments

## **3.4 Recommendations**

- Monitoring and Evaluation exercises should be given necessary attention and support to ensure efficient and effective project implementation.
- Departmental Heads should be entreated to submit their quarterly reports to the DPCU on time.
- Payment for work done by contractors should be done on time.
- Memos to activities should be written two weeks before implementation and must be given urgent attention
- Timely release of Funds to guarantee timely execution of programmes and projects.
- Exploitation of other IGF sources aside the conventional sources should be carried out by the Assembly.
- Improve the infrastructural and institutional capacity of sub-district structures to enhance their operations.
- The Assembly should invest in the procurement of office facilities and equipment to improve productivity levels of staffs.
